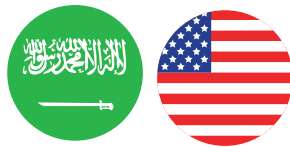
2024 HIGHLIGHTS

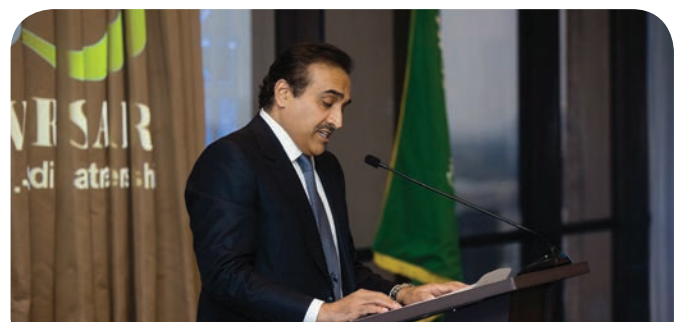
U.S.-Saudi Business Council Celebrates 30th Anniversary of Founding

From September 25-27, 2024, the Business Council organized a series of programs and meetings during the visit of the Saudi Ministry of Industry and Mineral Resources (MIM) to the U.S. The Saudi delegation, led by H.E. Bandar AlKhorayef, Minister of MIM, and H.E. Khalid AlMudaifer, Vice Minister of MIM, participated in MINExpo 2024 in Las Vegas, where the Council facilitated targeted floor meetings, site visits, and a gala dinner. During the visit, the USSBC facilitated the signing of a Memorandum of Understanding (MOU) between Mussel Polymers, Inc. and Almajdouie Group, which sets the foundation for a new polymers manufacturing plant in Saudi Arabia. MIM's trip concluded in Los Angeles with an executive networking briefing.

USSBC, MISA Foster Business Development Opportunities in Saudi Manufacturing Sector at Houston Roundtable



On December 10, 2024, the Business Council, in collaboration with the Ministry of Investment Saudi Arabia (MISA), hosted an exclusive Executive Roundtable in Houston. The event brought together senior representatives from leading U.S. companies and Saudi Government executives in the industrial sector to explore significant opportunities within Saudi Arabia's thriving manufacturing sector. The MISA delegation was led by Abdullah Alkhodair, Associate Director of MISA's Americas Office, and the program included a networking lunch and one-on-one meetings, offering attendees ample opportunities to connect with MISA officials and other participants.

On June 28, 2024, the USSBC, in partnership with the U.S. Chamber of Commerce hosted a Business Roundtable alongside the 8th U.S.-Saudi Trade and Investment Framework Agreement (TIFA) meeting between the U.S. and Saudi Government delegations led by the United States Trade Representative (USTR) and the Saudi General Authority of Foreign Trade (GAFT).

The roundtable aimed to enhance bilateral economic ties between the United States and Saudi Arabia, serving as a platform to discuss business opportunities and challenges, foster collaboration, and overall contribute towards promoting trade and investment between the two countries' business communities. The event was attended by over 115 representatives of U.S. and Saudi private sector and government agencies.

Business Council, GACA Promote Latest Developments and Opportunities in the Saudi Aviation Sector

Abdulaziz Al-Duailej, held discussions with more than 140 attendees, including over 100 U.S. C-suite executives and representatives from large Fortune 500 companies and SMEs from matarat holding, the Public Investment Fund, Saudi Air Navigation Services, Saudia Cargo, Riyadh Air & other key Saudi Aviation stakeholders Participants. Participants represented areas such as airport architecture, engineering, planning and operations, cargo facilities development, management and construction, among others.

SUCCESS STORIES FROM 2024



The Council introduced the Saudi Theater and Performing Arts Commission, under the Ministry of Culture, to a U.S. educational institution. Following continued discussions, the two parties signed a contract in 2024 to develop a Theater Academy, valued at more than **\$100 million**



In early 2024, following facilitation by the USSBC, a U.S. member company engaged in negotiations with Aramco for the procurement of seven unconventional rigs, secured a contract valued at **\$196 million**



In September 2024, the USSBC facilitated the signing of a notable Memorandum of Understanding (MOU) between Mussel Polymers, Inc. and Almajdouie Group during the visit to MINExpo by the Ministry of Industry and Mineral Resources (MIM). The MOU sets the foundation for a new polymers manufacturing plant in Saudi Arabia using Mussel Polymer’s propriety innovations in polymer manufacturing.

ECONOMIC RESEARCH

The Council's track record of success also derives from its in-depth economic research products and offerings. Meticulously sourced and frequently cited in media outlets, USSBC publications and reports offer insight and analysis into the latest economic trends, developments, and emerging opportunities for U.S. and Saudi businesses.

A premier publication produced by the Council's in-house economist is the Contract Awards Index (CAI) report, which provides a deeper analysis of major projects, as well as a regional and sectoral breakdown. In addition, the USSBC consistently updates members with Weekly Market Briefs, summarizing the week's major financial and economic news, as well as industry-specific reports.

In tandem with the release of new economic reports, the Council hosts webinars and virtual programs, offering participants the opportunity to engage directly with presenters, make inquiries, and share their own perspectives on topics under discussion.

The Council's Economic Research Department provides tailored research papers to its members upon request, covering a wide range of sectors including energy, finance, technology, healthcare, infrastructure, and more. Designed to meet the specific interests and goals of members, these reports deliver practical and focused analyses and underscore the Council's commitment to supporting members through the provision of latest market insight and intelligence.

COMMUNICATIONS AND PUBLIC RELATIONS

In 2024, the USSBC's Communications Team focused on expanding its outreach efforts to better connect with stakeholders. This year, the USSBC emphasized strengthening relationships with Saudi media outlets and trade publications across the United States to enhance visibility and engagement. Additionally, the Council continued to prioritize social media outreach alongside a robust traditional media strategy. These efforts supported the effective promotion of the Council's events, publications, and member initiatives.

The Communications Team works to enhance member visibility, engage with target audiences, and publicize news about its members' and partners' products, services, and innovations to both U.S. and Saudi audiences. Additionally, the Communications Team distributes exclusive publications to its members, such as economic reports, market updates and insights, major industry news, and event announcements.



Media: Successfully pitched **45 print** and **81 online** hits promoting USSBC economic reports, state visits, events, trade missions, etc. across top tier publications such as Al Ekhbariya (On-Air), Arab News, Construction Briefing, Asharq Al-Awsat, Al Riyadh Newspaper, Construction Week, and others.



LinkedIn: The Council added **350 new followers** since the start of 2024 for a total of **10,997 followers** on LinkedIn. The social media platform serves as a forum through which the Council shares news, economic reports, and connects with current and prospective members. The platform also is important to the USSBC's outreach efforts when inviting attendees to events and missions.
